Ravichandran**, Professor & Dean Academics, presented a short note about the Bucket System for elective courses under the Regulations VTR UGE 2021 to be operative from the summer semester of the Academic Year 2024-25.

Summary Note:

Our institution has been following the Choice based Credit System, since 2015. The students are free to handpick the electives of their own choice. This enables students to tailor their learning journey, honing the skills and expertise as they desire across various specialized fields by adding courses one by one in the elective categories.

However, students are facing some minor issues like satisfying the pre-requisites before opting for a particular course, completing the courses before the 9 month+ internships in industries or in universities abroad, missing the registration of certain courses in the previous semester and trying to register them at a later stage etc.,

Moreover, the examination schedules are also unique for every student based on the courses he/she has registered and it may also be spaced either continuously or in non-periodic gaps extending till last day of the examination session.

To address these issues and to strengthen the CBCS, it is proposed to implement the bucket/basket system in the institution in line with the practice observed in other leading universities. Each bucket will have a set of mandatory foundation and programme specific courses along with supplemented by a range of elective options. All the buckets will have the same mandatory courses whereas the set of electives will differ and a student is free to choose any bucket/basket.

These buckets will be so designed that, if the student opts for a specific set of electives in one semester, they can advance to move specialized elective courses in subsequent semesters, ensuring a coherent and progressive academic journey.

This will enhance the better deliverability of courses right on the intended semesters and also will help the students to complete all the required courses before 6 month/ 9 month internships thereby maximizing their competency level for the professional world.

The members welcomed the proposal of introducing the bucket system of elective courses. **Dr Krishnan Baskar**, member opined that, the bucket system of elective courses would be much helpful in the effective implementation of CBCS.

Dr Sankaranarayanasamy, member suggested to conduct workshop to the faculty members to familiarise with the bucket system of elective courses and procedures there on while in offering the elective courses.

Ravichandran, Professor & Dean Academics, thanked the members for the suggestions and he assured to arrange workshop and training programmes to the HoDs and concerned faculty members to make them aware of the bucket system of elective courses for smooth implementation from the Academic year 2024-25.

Summary Note:

As per the National Education Policy (NEP) 2020, a committee has been constituted under the chairmanship of Dr. K. Radhakrishnan to submit the report on "Transformative Reforms for Strengthening Assessment and Accreditation of Higher Education Institutions in India". The report which was submitted by the committee has been approved by the Ministry of Education on 16th January 2024. The salient features of the recommendations are;

Binary Accreditation (Either accredited or not accredited) rather than grades with an aim to encourage all the institutions to get on-boarding in the accreditation process thereby creating a quality culture in the higher education system. The binary accreditation is also in line with the best practices followed from many leading countries in the world.

Maturity-Based Graded Accreditation: Level 1 to 5 to encourage the Institutions to raise their bar, continually improve, evolve in-depth or in-breadth in disciplines from 'Level 1' to 'Level 4' as Institutions of National Excellence, and then to 'Level-5', i.e. Institutions of Global Excellence for Multi-Disciplinary Research and Education. The leveled accreditation shall enable Indian Institutions to significantly improve their quality and position themselves among global top institutions.

Based on Dr. K. Radhakrishnan's committee report, the Executive Committee of NAAC in its 104th meeting held on 27th January 2024 decided the following.

The recommended reforms shall be implemented in two stages. In the first stage, the Binary accreditation will be implemented in the next four months and no new applications will be accepted as per the present methodology thereafter. Institutions that have applied and are applying in the next four months shall have the option to either go by the present process or by the new methodology of binary accreditation. The maturity-based graded levels will be implemented by December 2024.

Additionally, it aims to ensure the integrity and transparency of institutional data by centralizing it through a One Nation One Data Platform, serving various purposes such as approval, accreditation, and ranking.

It is submitted that due to the increased demand for B.Tech. Computer Science and Engineering programme, the intake of students for this particular programme is increased from 1104 to 1320. The intake of students for B.Tech. Civil Engineering programme is reduced from 60 to 30 for the academic year 2024-25.

In the case of Post Graduate programmes, there is reduction from 18 to 12 for certain programmes viz (Aeronautical Engineering (Unmanned Aerial Vehicle), Big Data Analytics, Biotechnology, Computer Science & Engineering, Embedded Systems & Technologies, Information & Cyber Security and Power Electronics). Secondly due to the increased demand for the M.Tech. Industrial Safety & Engineering programme, the intake is increased from 18 to 36.

Lastly as the admission for M.Tech. Network Engineering programme is continuously less than the threshold number for the last few years, approval is sought for closure of the programme from 2024-25 onwards.

Summary Note:

The UGC has notified UGC [Categorization of Universities (only) for Grant of Grade I [Autonomy]] Regulations, 2018 on 12th February, 2018 in the Gazette of India.

The proposal submitted by the Vel Tech Rangarajhn Dr. Sagunthala R & D Institute of Science and Technology (Deemed to be University) has been examined, processed, and considered by the UGC for the up-gradation of Vel Tech Rangarajan Dr. Sagunthala R & D Institute of Science and Technology as Category-I Deemed to be University as per the provisions of the above UGC Regulations. Accordingly, the Deemed to be University shall now be eligible for all the benefits as stipulated under Clause 4 (Dimensions of Autonomy for Category-I Universities) of the UGC Regulations.

Similarly, the University Grants Commission in its 574th meeting held on 03.11.2023 considered the application submitted by our institution and decided to grant 12B status to Vel Tech Rangarajan Dr. Sagunthaia R & D Institute of Science and Technology, (Deemed to be University) subject to the condition that the financial assistance under all UGC schemes shall be limited to those relating to teachers and students only.

Accordingly, the Vel Tech Rangarajan Dr. Sagunthala R & D Institute of Science and Technology, (Deemed to be University) is included under section l2B of the UGC Act 1956 to be eligible for central assistance. The Acknowledgement has been submitted to the UGC as per this official communication no. VT/R/L/UGC-Grant of graded autonomy/23-24/051 dated 16.11.2011 along with the relevant documents in person for inclusion of the Institution in the list of Institutions in the country coming under Category I deemed to be Universities and publication of the same in the UGC official Website.

The Vice Chancellor, placed it before the Academic Council to report the progression of School of Mechanical and Construction, School of Law and their academic achievements.

a) School of Mechanical and Construction.

Dr.N. Lenin, Professor & Dean - School of Mechanical and Construction, presented the Progression of School of Mechanical and Construction and their academic acheivements.

Summary Note:

The School of Mechanical and Construction is comprised of the Aeronautical, Automobile, Civil, and Mechanical Engineering departments. Civil Engineering had been accredited for three years by the National Board of Accreditation (NBA) in their second cycle, which was assessed in August 2022. Aeronautical and Mechanical Engineering departments have been accredited by the National Board of Accreditation in March 2023 for the next three years. In the academic year 2023-2024, 747 students were enrolled in the School of Mechanical and Construction. On this, 585 students were in UG programs (Aeronautical: 178, Automobile: 11, Civil: 128, and Mechanical: 268), and 127 students were in PG programs (Aeronautical: 6, Civil: 43, and Mechanical: 78). 35 scholars were admitted to their Ph.D. programs (Aeronautical: 6, Civil: 7, and Mechanical: 22).

The School of Mechanical and Construction has a well-qualified and experienced team of faculty members in the respective disciplines. Presently, 92 full-time faculty members are working at SoMC. 27 are designated as professors, 15 as associate professors, and 50 as assistant professors. On the qualification list, 1 is a post-doctoral fellow, 72 faculty members hold doctoral degrees, 17 faculty members are pursuing their Ph.D., and 2 faculty members are post-graduate degree holders.

The SoMC faculty members are actively participating in research activities. Noble guidance is being provided to all U.G. and P.G. students in their project work. Doctoral faculty members are guiding the Full Time and Part Time research scholars.

Faculty members of SoMC had published 287 journal articles in WoS and Scopus journals from January 2023 to February 2024, with huge citations around 2000. 13 patents were awarded and 17 patents were published to the credit of the faculty members of SoMC in the AY 2023–24.

The funded projects with the total worth of Rs. 99 lakhs were received from various funding agencies such as DST, SERB, ISRO, DRDO, etc. in this academic year. A total of 25 consultancy projects worth Rs. 36.74 lakhs were received from various industries. 30 project proposals had been submitted by SoMC faculty. 13 research scholars at SoMC had completed the Ph.D. degree from January 2023 to February 2024.

Students are continuously encouraged to participate in various events, and the outcome is that 101 students participated in 24 events and won numerous and prestigious awards. 24 students of SoMC are undergoing project internships in world-top-ranked institutes with scholarships, and 83 students are doing their project internships at leading industries all over India. Regarding placements, 198 students out of 458 graduates have been placed it in premier MNCs and industries to date, and 22 students are pursuing their higher studies abroad and in India.

The SoMC raised the graduation ratio to 90%, with Aeronautical at 85%, Automobile at 94%, Civil at 79%, and Mechanical at 95% in the 2023 graduation.

Dr.N. Lenin, Professor & Dean - School of Mechanical and Construction, moved that "the Progression of School of Mechanical and Construction and their academic acheivements", be recorded.

b) School of Law.

Prof. Dr. B. Venugopal, Professor & Dean - School of Law, presented the Progression of School of Law and the academic acheivements.

Summary Note:

The School of Law started in the year 2018 and offers undergraduate programmes of B.A.LLB(Hons), B.Com LLB(Hons) and also Ph.D Programmes . There are more than 50 faculty members in the school and 928 students of which 530 are boys and 398 are girls.

The Academic year 2023-24 has been an eventful year so far. The School of Law organized a Two Days National Seminar on the Interplay of Women, Law, and Society - Issues and Challenges on the 10th and 11th of November 2023.

On the 10th, Honorable Dr. Justice P. Devadass, Former Judge of Madras High Court and currently serving as the Lokayukta Judge was the Chief Guest for the Inaugural Ceremony. Adv. Dr. Shantha Kumari, President of the Tamil Nadu Association of Women Lawyers, was the Guest of Honour. Vice Chancellor Prof. S. Salivahanan and Deans of School of Media Studies and School of Management Studies graced the occasion. The technical sessions were conducted after the inaugural ceremony. On the 11th, research paper presentations were held in seven venues simultaneously. Mr. M.D. Arifur Rahman, Second Secretary & Head of Chancery, Deputy High Commission for the People's Republic of Bangladesh, Chennai, India was the chief guest for the valedictory function and he also released the journal titled ' Interplay of Women, Law, and Society - Issues and Challenges'. Prof. Dr. Gowri Ramesh, Registrar of Tamil Nadu Dr.Ambedkar Law University, also graced the occasion as the Guest of Honour .

The School of Law celebrated Constitutional Day, a significant occasion that marks the adoption of the Constitution of our nation. Mr G Ramar, Assistant Commandant, CRPF, Avadi, Chennai was the chief guest for the event organised on 27.11.2023.

The School of Law conducted the first intra collegiate 'Crime Scene Investigation Competition' on 14/10/2023. The Competition is about introspecting a crime scene to establish the possible link between suspect, victim, and witnesses in relation to a criminal event.

The event was judged by Mr. Vijay Karthik, Faculty of Law, Dr.Ambedkar Govt Law College, Tiruvallur, Ms. Indira, Faculty of Law, Dr. Ambedkar Govt Law College, Chengalpattu and Mr. Anbalagan, Assistant Commissioner of Police, Avadi.

A significant achievement of the School this year was that for the second consecutive year the funding from ICSSR project was awarded to its faculty. Dr. K. Barathiraja, has been awarded ICSSR: Minor Research Project-2023-24with a grant of Rs. 9,65, 600/- for the duration of 1 year. Dr. K. Illakiya, was awarded ICSSR: Minor Research Project - 2022-23 with a grant of Rs. 4,55,000 for the duration 1 year.

The School conducts various outreach programmes towards legal awareness and legal aid. On 31-05-2023, in the village Koduvalli, an awareness campaign on child rights and also helpline numbers were held. On 02-06-2023 in the village Vellanur, awareness campaign on the rights of the women under the Indian Legal framework was organised.

On 14-07-2023, Anti Ragging awareness campaign was conducted in the School of Law premises. Legal Awareness Programme was conducted in Alamathi Village by Thiru. P.V. Sandilyan, Secretary and Senior Civil Judge, District Legal Service Authority, Thiruvallur District Court along with School of Law Students on 07.08.2023. Legal Awareness Programme was also conducted in the School of Law Campus by Thiru. P.V. Sandilyan, Secretary and Senior Civil Judge, District Legal Service Authority, Thiruvalur District Court, Thiruvallur on 22.09.2023. A legal awareness along with the village president was on 30.09.2023 in Kadhirvedu village.

By way of practical training, a visit to the Juvenile Justice Board in Kelly's, Chennai was organised from June 25^{th} to 27^{th} of 2023, both for the faculty and students.

So far five Special Lectures have been organised. A special lecture on Constitution Amendments: To Mend the Mind & Manage Crisis was delivered by Mr A. Jaison, Member of the Social Justice Monitoring Committee Government of Tamil Nadu on 6th October 2023. Lecture on Article 14- An Overview was delivered by Dr.G.Rajasekar, Head i/c, Department of Legal Studies, University of Madras on the 12th October 2023. A special lecture on the Law of Banking was delivered by Mrs K. S Begum, an Advocate and Notary Public on 20.10.023.A special lecture on Application of Statistical tools in Legal Studies was delivered by Dr.D. Sathiyavan, Prof and Head, Department of Econometrics, University of Madras on 8th February 2024. A special Lecture on Research Methodology in Socio- Legal Perspectives by Dr.M. Thamilarasu by Prof. and Head, Department of Sociology, University of Madras.

The faculty of the school regularly attend faculty development programmes to stay updated on the latest trends in the field of law. The faculty participate and present papers in seminars and conferences and they have also published research papers in edited books, peer reviewed journals, UGC approved journals and a few also have Scopus publication.

The students also bring accolades to the institution. 1st-year student Deepak D has won the "Gold Medal" at the 14th National Youth Games Championship 2023 in SILAMBAM- Surul Vaal under category 19, held at Chougule Sports College, Goa on 07th October 2023. S.Sandhiya & S.Hemavathy from IIIrd BA., LLB got 1st and 2nd Prize respectively in the Alternative Judgement writing competition conducted by Christ Academy of Law, Bengaluru. Sampathi Rao Sindhu (VTA 2377), II Year B. Com LLB, Naval Wing Cadet has participated in the 75th Republic Day Parade 2024.

She has also been selected to participate in the Youth Exchange Program (YEP) as a representative of India in other countries. She will be visiting 10 countries.

B.Com Summary Note

The 3rd Board of Studies of the Department was held on 1st December 2023 for the B.Com. Programme for the winter semester of the Academic Year 2023 – 2024 were presented. The following items were discussed by the members and the BoS recommended to the ACM.

- The Academic Expert Dr. J.Arul Suresh from Loyola suggested including Case Studies in the courses Fintech and Artificial Intelligence.
