





### **MINUTES**

### A. Opening

He then summarized some of the key academic activities and events that had taken place since the last Board of Management meeting on January 28, 2024.

The Chairperson briefed the measures taken towards the effective implementation of the National Education Policy (NEP) 2020, emphasizing that the institution was committed to aligning its programs with the new policy's guidelines.

Regarding the institution's standing, the Chairperson proudly stated they were in the midst of the National Institutional Ranking Framework (NIRF) validation process. It is submitted that Prof. S. Salivahanan, Vice Chancellor completes the age of seventy years on 03.10.2024.

In this connection, it is submitted that the clause 23B(4) - UGC Regulations (Institutions Deemed to be Universities), 2023 states as follows.

"The Vice Chancellor shall hold the office for a term of five years from the date of which he or she enters upon his or her office or until he or she attains the age of seventy years, whichever is earlier shall be eligible for re-appointment for one more term".

"Provided that notwithstanding the expiry of the said period, he shall continue in the office until his successor is appointed and enters upon his office, however, in no case, the Vice Chancellor shall hold office beyond the age of seventy years".

It is, therefore, placed before the Board of Management with regard to appointment of a new Vice Chancellor in the place of Prof. S. Salivahanan as he completes 70 years of age on 03.10.2024 and constitution of Search Cum Selection Committee (SCSC) as per the UGC Regulations (Institutions Deemed to be Universities), 2023, with the following members:

- 1. a nominee of the Chancellor, who shall be a reputed academician as the Chairman of the Search Cum Selection Committee (SCSC).
- 2. a nominee of the Chairman, University Grants Commission (UGC).
- 3. an academician, with not less than ten years' of service as Professor to be nominated by the Board of Management.

- 2. finalisation of the name of BoM Nominee for the SCSC.
- 3. grant of approval by the BoM for requesting the UGC to suggest the UGC Nominee for the SCSC.
- 4. submission of the names of the BoM nominee and the UGC nominee to the chancellor for his assent and further action.

The Board of Management considered the Constitution of the Search Cum Selection Committee and decided that the Search Cum Selection Committee be constituted in view of the reason that the present Vice Chancellor attained the age of 70 years on 30.10.2024.

Prof. H.S. Shan, the External member has proposed the name of Prof. B.S. Murty, Director, Indian Institute of Technology, Hyderabad as the BoM nominee for the Search Cum Selection Committee. Prof. A.T.Ravichandran, Dean (Academics) seconded it. The Board unanimously approved the name of Prof. B.S. Murty for the SCSC as its nominee.

The Dean (Academics) has outlined some of the important discussions as in the Gist of the Academic Council proceedings is placed at Appendix-E. One such important subject discussed was the new Bucket system for the selection of elective courses from different combinations / groups termed as buckets. This approach aims to shorten the examination days by grouping elective courses in to distinct buckets ensuring students do not miss out on critical courses during the process of selection.

Prof. B.S. Murty and Prof. V. Jagadeesh Kumar advised that careful attention must be paid to ensure that students' interests should not be compromised when selecting elective courses from the distinct buckets. They emphasized that the changes should prioritize student needs and ensure flexibility in course choices while processing the grouping of courses.

The Dean (Academics) informed that the Academic Council had thoroughly discussed the topic of a "Multiple Exit and Entry" system. The council resolved to explore the feasibility of adopting this system, ensuring it aligns with AICTE and UGC guidelines. This agenda will have to be again placed before the Academic Council with the clarification on certain points sought by the External members of the Council for its consideration and approval. Prof. Murty elaborated on the distribution of credits across core and elective courses, clarifying how degrees or diplomas have to be awarded to candidates who meet the credit requirements for diplomas and degrees.

Prof. S. Salivahanan Vice Chancellor He highlighted a system where students enrolled in degree programs can earn a diploma or a degree even if they don't complete the entire course, He ensured that he would provide guideline, if necessary.

He reiterated that there must be a safety net to ensure that no student leaves the program without achieving some form of academic credential.

The Finance Officer submitted the minutes of the Finance Committee along with the proposed budget. During the discussion, Prof. S.P. Thyagarajan pointed out that the term "revenue" should not be used anywhere in this document to avoid potential legal complications and issues related to tax imposition by the IT Department. As an alternative to using the term "revenue," "resources" can be used instead.

Prof. H.S. Shan sought clarification as to where consultancy-related accounts are indicated in the budget. The Finance Officer clarified the specific account head wherein these accounts are mentioned. After elaborate discussions, the Board members unanimously passed the proposed budget for the financial year 2024.25.

The Dean of Quality Assurance presented the proceedings of the Internal Quality Assurance Cell (IQAC) meeting held on February 10, 2024, highlighting key discussions on accreditation perspectives and excellence, aligning with the National Education Policy (NEP) 2020. This included a detailed examination of the status of maturity-based graded accreditation levels.

The Dean presented the placement statistics submitted by the Dean of Campus to Corporate, alongside the various measures undertaken to improve placement outcomes. During the discussion the External members suggested several approaches to further boost placement outcomes, such as implementing semester-long projects, engaging students in industry-related projects, and other initiatives aimed at attracting placements from leading industries.

The Dean (Academic Research) presented some of the significant decisions taken at the 25<sup>th</sup> meeting of the Academic Research Board held on March 18, 2024 such as Stipend revision from Rs.15,000/- to Rs.25,000/- to International Scholars, disbursement of cash incentives to research scholars contributing to Q1 journals, categorization of Ph.D. candidates under Dormant category, Revision of publication requirements for Ph.D. scholars in the School of Law, admitting B.E/B.Tech.

Prof. S. Salivahanan Vice Chancellor students directly into Ph.D. based on GATE score, vacant supervisor positions in the departments, Budget for the centre of Academic Research, recognition of eligible faculty members as Ph.D. Supervisor etc. at the meeting. Prof. B.S. Murty suggested to explore the feasibility of increasing stipend to the Full time scholars at par with the salary of ME qualified faculty.

Prof. Jagadeesh Kumar brought up an important point about the naming of "Academic Research" centre, specifically in relation to the Board of Research Studies for Ph.D scholars. He suggested that the term "Academic Research" might not be the most appropriate term and that it would be more fitting to refer to it simply as the "Board of Research Studies" or a similar term to provide clarity and to avoid potential confusion with broader academic research activities.

The significant activities of office of Deans and their proposed futuristic activities were presented by the respective Deans.

## 58.12.1 Campus to Corporate

The Dean (Campus to Corporate) reported that out of a total of 1,223 students who registered for campus placements, 684 had secured positions through the placement process. The highest salary package offered was 17.9 lakks per annum (LPA), while the average package stood at 4.56 LPA. These placements covered a range of domains, including engineering, management, computer science, and other fields, showcasing the diverse academic offerings at the institution.

The placement process was facilitated through 229 campus recruitment drives, conducted by a variety of esteemed companies representing different sectors. These drives provided students with the opportunity to engage with industry professionals, gain insights into various job roles, and demonstrate their skills and abilities. The range of recruitment drives ensured that students from a variety of academic backgrounds had ample opportunities to explore career paths that matched their interests and qualifications.

### 58.12.2 Research & Development

Dr. P. Chandrakumar, Dean (R&D) presented a brief summary of the activities for the year 2023-24. He reported that the institution had 1,622 publications indexed in Scopus and 519 in the Web of Science. In terms of patents, a total of 31 were filed, 29 were published, and 25 were granted during this period. Regarding seed funding for faculty members for the fiscal year 2023-24, the institution had a top-up fund of Rs. 22.71 lakh, with Rs. 18.26 lakh disbursed from a seed fund of Rs. 30.52 lakh. Looking ahead to research development funds for the fiscal year 2024-25, a sanctioned amount of Rs. 50 lakh was allocated for 75 faculty members.

In terms of consultancy activities during the fiscal year 2023-24, there were 32 consultations, generating Rs. 48,45,262 in revenue. Additionally, sponsored research projects for the same period included 14 newly sanctioned projects and 24 ongoing projects, with a total of Rs. 1.28 lakh received from various funding agencies. Dean Chandrakumar also mentioned the incentives provided for projects, patents, publications, and consultancy. The incentives included Rs. 7.72 lakh for sponsored projects, Rs. 3.94 lakh for patents, Rs. 33.77 lakh for publications, and Rs. 7.93 lakh for consultancy.

Prof. S.P. Thyagarajan emphasized the importance of creating an environment where faculty are encouraged to pursue innovative research. This could be achieved through recognition programs, incentives for outstanding projects, and providing resources that facilitate research activities. Another key suggestion was to actively promote and nurture research project talent among faculty members. He also suggested for a systematic approach to identifying and developing research potential within the institution. This would involve using data-driven methods to assess the strengths and weaknesses of current research programs and identify areas for growth.

A comprehensive assessment would help determine which faculty members or research teams are best suited to pursue specific projects and guide them in developing their research agenda. To further support faculty in their research endeavors, Prof. S.P. Thyagarajan recommended forming school-level mentoring committees. These committees would consist of both internal faculty members and external experts from various fields. The external experts would bring fresh perspectives and industry knowledge. These committees would provide guidance, mentorship, and constructive feedback to faculty working on research projects.

As a final suggestion, Prof.S.P.Thyagarajan proposed to organize group discussions to foster collaboration and idea exchange among faculty and researchers. These discussions would serve as a platform for brainstorming, sharing experiences, and building interdisciplinary connections. Prof. B.S. Murty emphasized the importance of selecting mentors who possess deep domain knowledge in their respective fields. These mentors should have extensive experience and expertise, allowing them to provide valuable insights and guidance to researchers and faculty members. Domain knowledge ensures that mentors can offer relevant advice, spot emerging trends, and help shape research projects in a way that aligns with current industry or academic developments.

Another key suggestion from Prof. B.S. Murty is to compensate mentors with a respectful honorarium. This honorarium should reflect the value of their time, expertise, and contributions to the institution's research initiatives. Offering a fair honorarium demonstrates that the institution recognizes the mentors' professional experience and is committed to fostering a culture of respect and appreciation for their work. It also serves as an incentive for mentors to remain engaged and motivated in their roles. He recommended that each department within the R&D framework have at least one designated mentor. This approach ensures that every department has access to a dedicated mentor who understands the unique challenges and opportunities within that field. By following these suggestions, the institution can establish a robust mentorship system within its R&D department. The presence of knowledgeable mentors, equitable compensation, and a dedicated mentor for each department can significantly contribute to the success and growth of the institution's research.

RESOLVED to approve and record the significant activities during the academic year 2023-24 and proposed futuristic activities of the centre of the Research and Development.

#### 58.12.3 Centre for Academic Research

The Dean of Academic Research outlined several key activities and initiatives undertaken by the Centre for Advanced Research (CFAR) for the academic year 2023-24. Efforts to enhance admissions included revising stipends for national and international scholars and running campaigns to raise awareness of the benefits of studying at Vel Tech. Quality improvement initiatives featured the introduction of "Intellectual Talks," an annual research scholar meet, and recognition of patent contributions, along with appreciation awards for top-performing scholars.

Cash incentives for publications in high-quality journals and the use of the NPTEL platform for coursework were also part of the strategy to encourage research excellence. Special standards for the School of Law and motivational initiatives for conference travel were established. Looking ahead, CFAR proposed admitting students to the PhD program with a B.E/B.Tech degree and a GATE score, promoting interdisciplinary collaboration, and introducing PhD programs in commerce, multimedia, and law.

Prof. S. P. Thyagarajan has brought to the notice that the decision taken by the Executive Committee of the National Assessment and Accreditation Council (NAAC) on 27.01.2024 citing major reforms in its accreditation process. In the first stage, a "binary accreditation system" will be implemented in the next four months, which will replace the present system of ranking (C to A++) of higher education institution (HEIs).

According to the NAAC, the new binary accreditation system is in line with the best practices followed globally. The NAAC said the new system will encourage all the institutions to get "on-boarded" in the accreditation process, thereby creating a quality culture in the higher education system. The new changes are proposed with the strategic intent to be consistent with the National Education Policy (NEP) 2020 and one nation and one data concept and lead a new wave of transformative reforms.

While the binary accreditation is aimed to encourage all institutions to get on board the NAAC accreditation process and improve the overall quality of higher education in India, the Maturity-Based Graded Accreditation (MBGA) is aimed to encourage institutions to raise their bar by improving the standard of imparting education. Institutions from Level 1 to Level 4 will be classified as 'Institutions of National Excellence' and institutions of Level 5 will be classified as 'Institutions of Global Excellence for Multi-Disciplinary Research and Education'.

These changes are proposed in line with the global best practices set by leading countries in the field of education. The implementation of these recommendations will be done in 2 stages. In stage one, the binary accreditation will be implemented in the next four months. The MBGA will be implemented by December 2024.

Prof. S. P.Thyagarajan pointed out that the importance of having a robust data at this context which is very much essential to meet out the requirement of parameters of MBGA and IQAC should take a note of it and take all initiatives in this regard.

The Finance officer, while presenting the minutes of the Finance Committee detailed the funds allocated under different heads, status of the Funds allocated and the details of the reallocated funds based on the merit and necessity. The Finance Officer has also presented the Audit Statements etc. for consideration and approval by the Board of Management.

Prof. H.S. Shan sought clarifications with regard to the funds allocated for sponsored research and sports which he opined that they were not sufficient. Secondly Prof. H.S. Shan suggested that whenever the budget allocations are made by transferring funds from one account head to the other owing to less amount spent under one particular head and more amount needed for another account head, the reasons for transference of funds should be given. Prof. B.S. Murty has suggested for allocation of matching grant and sufficient funds for technological development.

In reply to the clarifications sought by the external members, Mrs. Rangarajan Mahalakshmi Kishore representing Sponsoring Trust Nominee enlightened the process of budget preparation starting from receiving proposal from the Deans, Head of the Departments and Heads of the Sections till the finalisation of the Budget. She pointed out that the funds for the Departmental activities were based on the requirement submitted by the respective Deans and Heads of Departments and Sections. The Budget Committee under the Chairmanship of the Vice Chancellor conducted meetings frequently

to check as how efficiently the funds allocated under different account heads are utilised every on and off. She also ensured that the suggestions and inputs of the external members would be taken into consideration and the Chairman of the Finance Committee would follow them accordingly.

# 57.8 To consider and approve the proposal of addition / reduction of Intake in UG & PG Programmes for the Academic Year 2024-25.

It is submitted that due to the increased demand for B.Tech. Computer Science and Engineering programme, the intake of students for this particular programme is increased from 1104 to 1320. The intake of students for B.Tech. Civil Engineering programme is reduced from 60 to 30 for the academic year 2024-25.

In the case of Post Graduate programmes, there is reduction from 18 to 12 for certain programmes viz (Aeronautical Engineering (Unmanned Aerial Vehicle), Big Data Analytics, Biotechnology, Computer Science & Engineering, Embedded Systems & Technologies, Information & Cyber Security and Power Electronics). Secondly due to the increased demand for the M.Tech. Industrial Safety & Engineering programme, the intake is increased from 18 to 36.

Lastly as the admission for M.Tech. Network Engineering programme is continuously less than the threshold number for the last few years, approval is sought for closure of the programme from 2024-25 onwards.

The proposal for the changes in the increase / reduction of the above UG / PG programmes was submitted for consideration and approval.

Prof. B.S. Murthy pointed out that the education system has undergone significant transformation, focusing on making education accessible, high-quality, and future-ready. The COVID-19 pandemic has further accelerated this transformation. Hybrid learning is one such model that combines the benefits of online and offline learning. Hybrid learning offers flexibility, personalization, and a more student-centric learning experience.

He suggested that Vel Tech could offer online hybrid courses to be made open to all as they would attract a large number of people from anywhere in the world. The Grades, Credits or certificates might be given to those who complete the courses. And Evaluation might be done on online itself with the external experts. He emphasized that this Institution might consider teaching courses through online as in IITs considering the facility available.

The Evaluator should be from reputed Institutions, IITs and MITs. The faculty members might be engaged for handling classes could be paid substantial honorarium and he suggested that there would be no practical of lab oriented classes. The fee might be collected from the students for registration of the courses.

Dr. B. Venkataraman, while endorsing the view of Prof. B.S. Murthy that some of the trend set areas like Artificial Intelligence, Internet of Things (IoT), Solar innovations, Wind power enhancement, Machine Learning, Big data, Innovative Design and Simulation etc. might be taken up for this purpose.

He is of the opinion that both traditional and online education methods would foster a dynamic and interactive learning environment.

- Dr. P. Suresh, Dean (International Relations) presented the descriptive note on the activities of the office of the International Relations such as Faculty Mobility, Student Mobility, Higher Studies, Scholarships and Fellowships etc. with statistical data and photographs. Prof. B.S. Murty spoke on the Semester-long Internship and the projects at the context of IIT as they used to be beneficial to the students. He explained as now students get benefits from these projects / Internship.
  - 1. Students who aspire for their dream jobs sign-up with companies for a Semesterlong projects Internship program with an opportunity to convert into a full time position.

2. Often the companies visiting the campus for recruitment also offer students an opportunity to join as interns before the students join in the full time positions in the same company or so, the students might have a gradual transition from student to their full time roles.

He suggested that the curriculum be designed in such a way to cover the Core Courses within the sixth semester for which the students might get appropriate credits (i.e. for the students who opted for a Semester-long project only), would be evaluated twice by the industry mentor and twice by the institute faculty mentor. A team of two faculty members might carry out the final evaluation.

He pointed out that the IIT Hyderabad (IIT H) has brought a wonderful opportunity for final-year non-IIT engineering students to do an internship at their college. The institute has provided 150 internships across its 18 departments under the Summer Undergraduate Research Exposure (SURE) scheme. The internship is not open to IIT Hyderabad students but applicable only for the benefit of several students who may have failed to have their IIT dream due to low JEE scores or other unforeseen circumstances.

This is a golden opportunity for such aspiring students to get exposure and guidance from the IIT Hyderabad faculty.

Dr. V. Jagadeesh Kumar informed that the B.Tech. students of all three schools (Computer science and engineering, Electrical engineering and Mechanical engineering) of IIT used to avail a 6-months internship during their 7<sup>th</sup> semester (tentatively Mid-May—Mid-November).

While presenting the recommendations of the Faculty Selection Committee, Prof. E. Prof. E. The institution is very keen in maintaining the FSR ratio constantly.

**Dr. A. T. Ravichandran**, Professor & Dean Academics, presented a short note about the Bucket System for elective courses under the Regulations VTR UGE 2021 to be operative from the summer semester of the Academic Year 2024-25.

#### Summary Note:

Our institution has been following the Choice based Credit System, since 2015. The students are free to handpick the electives of their own choice. This enables students to tailor their learning journey, honing the skills and expertise as they desire across various specialized fields by adding courses one by one in the elective categories.

However, students are facing some minor issues like satisfying the pre-requisites before opting for a particular course, completing the courses before the 9 month+ internships in industries or in universities abroad, missing the registration of certain courses in the previous semester and trying to register them at a later stage etc.,

Moreover, the examination schedules are also unique for every student based on the courses he/she has registered and it may also be spaced either continuously or in non-periodic gaps extending till last day of the examination session.

To address these issues and to strengthen the CBCS, it is proposed to implement the bucket/basket system in the institution in line with the practice observed in other leading universities. Each bucket will have a set of mandatory foundation and programme specific courses along with supplemented by a range of elective options. All the buckets will have the same mandatory courses whereas the set of electives will differ and a student is free to choose any bucket/basket.

These buckets will be so designed that, if the student opts for a specific set of electives in one semester, they can advance to move specialized elective courses in subsequent semesters, ensuring a coherent and progressive academic journey.

This will enhance the better deliverability of courses right on the intended semesters and also will help the students to complete all the required courses before 6 month/ 9 month internships thereby maximizing their competency level for the professional world.

The members welcomed the proposal of introducing the bucket system of elective courses. **Dr Krishnan Baskar**, member opined that, the bucket system of elective courses would be much helpful in the effective implementation of CBCS.

**Dr Sankaranarayanasamy**, member suggested to conduct workshop to the faculty members to familiarise with the bucket system of elective courses and procedures there on while in offering the elective courses.

#### **Summary Note:**

As per the National Education Policy (NEP) 2020, a committee has been constituted under the chairmanship of Dr. K. Radhakrishnan to submit the report on "Transformative Reforms for Strengthening Assessment and Accreditation of Higher Education Institutions in India". The report which was submitted by the committee has been approved by the Ministry of Education on 16th January 2024. The salient features of the recommendations are;

**Binary Accreditation** (Either accredited or not accredited) rather than grades with an aim to encourage all the institutions to get on-boarding in the accreditation process thereby creating a quality culture in the higher education system. The binary accreditation is also in line with the best practices followed from many leading countries in the world.

**Maturity-Based Graded Accreditation:** Level 1 to 5 to encourage the Institutions to raise their bar, continually improve, evolve in-depth or in-breadth in disciplines from 'Level 1' to 'Level 4' as Institutions of National Excellence, and then to 'Level-5', i.e. Institutions of Global Excellence for Multi-Disciplinary Research and Education. The leveled accreditation shall enable Indian Institutions to significantly improve their quality and position themselves among global top institutions.

Based on Dr. K. Radhakrishnan's committee report, the Executive Committee of NAAC in its 104th meeting held on 27th January 2024 decided the following.

The recommended reforms shall be implemented in two stages. In the first stage, the Binary accreditation will be implemented in the next four months and no new applications will be accepted as per the present methodology thereafter. Institutions that have applied and are applying in the next four months shall have the option to either go by the present process or by the new methodology of binary accreditation. The maturity-based graded levels will be implemented by December 2024.

Additionally, it aims to ensure the integrity and transparency of institutional data by centralizing it through a One Nation One Data Platform, serving various purposes such as approval, accreditation, and ranking.

#### **Summary Note:**

It is submitted that due to the increased demand for B.Tech. Computer Science and Engineering programme, the intake of students for this particular programme is increased from 1104 to 1320. The intake of students for B.Tech. Civil Engineering programme is reduced from 60 to 30 for the academic year 2024-25.

In the case of Post Graduate programmes, there is reduction from 18 to 12 for certain programmes viz (Aeronautical Engineering (Unmanned Aerial Vehicle), Big Data Analytics, Biotechnology, Computer Science & Engineering, Embedded Systems & Technologies, Information & Cyber Security and Power Electronics). Secondly due to the increased demand for the M.Tech. Industrial Safety & Engineering programme, the intake is increased from 18 to 36.

Lastly as the admission for M.Tech. Network Engineering programme is continuously less than the threshold number for the last few years, approval is sought for closure of the programme from 2024-25 onwards.

#### Summary of Ph.D. Admission AY 2023-24 (Winter Semester)

The Centre for Academic Research received 209 applications through online. Out of 209 candidates, 25 candidates were exempted from written entrance examination, since they have qualified M. Phil/NET/SLET/GATE and 184 candidates shortlisted for entrance exam. Out of 184, 132 candidates were appeared for the entrance examination in which 100 candidates got eligible for the Interview. Totally 125 candidates including 25 exempted candidates got eligible for the Interview in various departments. Through the concerned department DRC, 91 candidates were selected and have been called for certificate verification. Finally, 69 candidates were admitted where 18 candidates registered in the Full-Time mode and 51 candidates registered in the Part Time mode.

#### Summary Note:

The proposal submitted by the Vel Tech Rangarajhn Dr. Sagunthala R & D Institute of Science and Technology (Deemed to be University) has been examined, processed, and considered by the UGC for the up-gradation of Vel Tech Rangarajan Dr. Sagunthala R & D Institute of Science and Technology as Category-l Deemed to be University as per the provisions of the above UGC Regulations. Accordingly, the Deemed to be University shall now be eligible for all the benefits as stipulated under Clause 4 (Dimensions of Autonomy for Category-l Universities) of the UGC Regulations.

Similarly, the University Grants Commission in its  $574^{th}$  meeting held on 03.11.2023 considered the application submitted by our institution and decided to grant 12B status to Vel Tech Rangarajan Dr. Sagunthaia R & D Institute of Science and Technology, (Deemed to be University) subject to the condition that the financial assistance under all UGC schemes shall be limited to those relating to teachers and students only.

Accordingly, the Vel Tech Rangarajan Dr. Sagunthala R & D Institute of Science and Technology, (Deemed to be University) is included under section l2B of the UGC Act 1956 to be eligible for central assistance. The Acknowledgement has been submitted to the UGC as per this official communication no. VT/R/L/UGC-Grant of graded autonomy/23-24/051 dated 16.11.2011 along with the relevant documents in person for inclusion of the Institution in the list of Institutions in the country coming under Category I deemed to be Universities and publication of the same in the UGC official Website.

#### a) School of Mechanical and Construction.

**Dr.N. Lenin**, Professor & Dean - School of Mechanical and Construction, presented the Progression of School of Mechanical and Construction and their academic acheivements.

#### **Summary Note:**

The School of Mechanical and Construction is comprised of the Aeronautical, Automobile, Civil, and Mechanical Engineering departments. Civil Engineering had been accredited for three years by the National Board of Accreditation (NBA) in their second cycle, which was assessed in August 2022. Aeronautical and Mechanical Engineering departments have been accredited by the National Board of Accreditation in March 2023 for the next three years.

In the academic year 2023-2024, 747 students were enrolled in the School of Mechanical and Construction. On this, 585 students were in UG programs (Aeronautical: 178, Automobile: 11, Civil: 128, and Mechanical: 268), and 127 students were in PG programs (Aeronautical: 6, Civil: 43, and Mechanical: 78). 35 scholars were admitted to their Ph.D. programs (Aeronautical: 6, Civil: 7, and Mechanical: 22).

The School of Mechanical and Construction has a well-qualified and experienced team of faculty members in the respective disciplines. Presently, 92 full-time faculty members are working at SoMC. 27 are designated as professors, 15 as associate professors, and 50 as assistant professors. On the qualification list, 1 is a post-doctoral fellow, 72 faculty members hold doctoral degrees, 17 faculty members are pursuing their Ph.D., and 2 faculty members are post-graduate degree holders.

The SoMC faculty members are actively participating in research activities. Noble guidance is being provided to all U.G. and P.G. students in their project work. Doctoral faculty members are guiding the Full Time and Part Time research scholars.

Faculty members of SoMC had published 287 journal articles in WoS and Scopus journals from January 2023 to February 2024, with huge citations around 2000. 13 patents were awarded and 17 patents were published to the credit of the faculty members of SoMC in the AY 2023–24.

The funded projects with the total worth of Rs. 99 lakhs were received from various funding agencies such as DST, SERB, ISRO, DRDO, etc. in this academic year. A total of 25 consultancy projects worth Rs. 36.74 lakhs were received from various industries. 30 project proposals had been submitted by SoMC faculty. 13 research scholars at SoMC had completed the Ph.D. degree from January 2023 to February 2024.

Students are continuously encouraged to participate in various events, and the outcome is that 101 students participated in 24 events and won numerous and prestigious awards. 24 students of SoMC are undergoing project internships in world-top-ranked institutes with scholarships, and 83 students are doing their project internships at leading industries all over India. Regarding placements, 198 students out of 458 graduates have been placed it in premier MNCs and industries to date, and 22 students are pursuing their higher studies abroad and in India.

The SoMC raised the graduation ratio to 90%, with Aeronautical at 85%, Automobile at 94%, Civil at 79%, and Mechanical at 95% in the 2023 graduation.

**Dr.N. Lenin**, Professor & Dean - School of Mechanical and Construction, moved that "the Progression of School of Mechanical and Construction and their academic acheivements", be recorded.

#### b) School of Law.

**Prof. Dr. B. Venugopal**, Professor & Dean - School of Law, presented the Progression of School of Law and the academic acheivements.

#### **Summary Note:**

The School of Law started in the year 2018 and offers undergraduate programmes of B.A.LLB(Hons), B.Com LLB(Hons) and also Ph.D Programmes . There are more than 50 faculty members in the school and 928 students of which 530 are boys and 398 are girls.

The Academic year 2023-24 has been an eventful year so far. The School of Law organized a Two Days National Seminar on the Interplay of Women, Law, and Society - Issues and Challenges on the  $10^{th}$  and  $11^{th}$  of November 2023.

On the 10th, Honorable Dr. Justice P. Devadass, Former Judge of Madras High Court and currently serving as the Lokayukta Judge was the Chief Guest for the Inaugural Ceremony. Adv. Dr. Shantha Kumari, President of the Tamil Nadu Association of Women Lawyers, was the Guest of Honour. Vice Chancellor Prof. S. Salivahanan and Deans of School of Media Studies and School of Management Studies graced the occasion. The technical sessions were conducted after the inaugural ceremony. On the 11th, research paper presentations were held in seven venues simultaneously. Mr. M.D. Arifur Rahman, Second Secretary & Head of Chancery, Deputy High Commission for the People's Republic of Bangladesh, Chennai, India was the chief guest for the valedictory function and he also released the journal titled 'Interplay of Women, Law, and Society - Issues and Challenges'. Prof. Dr. Gowri Ramesh, Registrar of Tamil Nadu Dr.Ambedkar Law University, also graced the occasion as the Guest of Honour .

The School of Law celebrated Constitutional Day, a significant occasion that marks the adoption of the Constitution of our nation. Mr G Ramar, Assistant Commandant, CRPF, Avadi, Chennai was the chief guest for the event organised on 27.11.2023.

The School of Law conducted the first intra collegiate 'Crime Scene Investigation Competition' on 14/10/2023. The Competition is about introspecting a crime scene to establish the possible link between suspect, victim, and witnesses in relation to a criminal event.

The event was judged by Mr. Vijay Karthik, Faculty of Law, Dr. Ambedkar Govt Law College, Tiruvallur, Ms. Indira, Faculty of Law, Dr. Ambedkar Govt Law College, Chengalpattu and Mr. Anbalagan, Assistant Commissioner of Police, Avadi.

A significant achievement of the School this year was that for the second consecutive year the funding from ICSSR project was awarded to its faculty. Dr. K. Barathiraja, has been awarded ICSSR: Minor Research Project-2023-24with a grant of Rs. 9,65, 600/- for the duration of 1 year. Dr. K. Illakiya, was awarded ICSSR: Minor Research Project - 2022-23 with a grant of Rs. 4,55,000 for the duration 1 year.

The School conducts various outreach programmes towards legal awareness and legal aid. On 31-05-2023, in the village Koduvalli, an awareness campaign on child rights and also helpline numbers were held. On 02-06-2023 in the village Vellanur, awareness campaign on the rights of the women under the Indian Legal framework was organised.

On 14-07-2023, Anti Ragging awareness campaign was conducted in the School of Law premises. Legal Awareness Programme was conducted in Alamathi Village by Thiru. P.V. Sandilyan, Secretary and Senior Civil Judge, District Legal Service Authority, Thiruvallur District Court along with School of Law Students on 07.08.2023. Legal Awareness Programme was also conducted in the School of Law Campus by Thiru. P.V. Sandilyan, Secretary and Senior Civil Judge, District Legal Service Authority, Thiruvallur District Court, Thiruvallur on 22.09.2023. A legal awareness along with the village president was on 30.09.2023 in Kadhirvedu village.

By way of practical training, a visit to the Juvenile Justice Board in Kelly's, Chennai was organised from June  $25^{th}$  to  $27^{th}$  of 2023, both for the faculty and students.

So far five Special Lectures have been organised. A special lecture on Constitution Amendments: To Mend the Mind & Manage Crisis was delivered by Mr A. Jaison, Member of the Social Justice Monitoring Committee Government of Tamil Nadu on 6<sup>th</sup> October 2023. Lecture on Article 14- An Overview was delivered by Dr.G.Rajasekar, Head i/c, Department of Legal Studies, University of Madras on the 12<sup>th</sup> October 2023. A special lecture on the Law of Banking was delivered by Mrs K. S Begum, an Advocate and Notary Public on 20.10.023.A special lecture on Application of Statistical tools in Legal Studies was delivered by Dr.D. Sathiyavan, Prof and Head, Department of Econometrics, University of Madras on 8<sup>th</sup> February 2024. A special Lecture on Research Methodology in Socio- Legal Perspectives by Dr.M. Thamilarasu by Prof. and Head, Department of Sociology, University of Madras.

The faculty of the school regularly attend faculty development programmes to stay updated on the latest trends in the field of law. The faculty participate and present papers in seminars and conferences and they have also published research papers in edited books, peer reviewed journals, UGC approved journals and a few also have Scopus publication.

The students also bring accolades to the institution. 1st-year student Deepak D has won the "Gold Medal" at the 14<sup>th</sup> National Youth Games Championship 2023 in SILAMBAM- Surul Vaal under category 19, held at Chougule Sports College, Goa on 07<sup>th</sup> October 2023. S.Sandhiya & S.Hemavathy from IIIrd BA., LLB got 1st and 2nd Prize respectively in the Alternative Judgement writing competition conducted by Christ Academy of Law, Bengaluru. Sampathi Rao Sindhu (VTA 2377), II Year B. Com LLB, Naval Wing Cadet has participated in the 75<sup>th</sup> Republic Day Parade 2024.

She has also been selected to participate in the Youth Exchange Program (YEP) as a representative of India in other countries. She will be visiting 10 countries.

#### B. ITEMS FOR DISCUSSION AND CONSIDERATION

## 22.5 To explore the perspective of "Accreditation and Excellence" in alignment with the National Education Policy (NEP) 2020

Dr. M. Rajeev Kumar, DQA, discussed the perspective of "Accreditation and Excellence" in alignment with the National Education Policy (NEP) 2020. DQA presented the report submitted by Dr. K. Radhakrishnan, Chairperson, Standing Committee of IIT Council, to the Ministry of Education (MoE).

- The National Education Policy (NEP) 2020 proposes implementing a Binary Accreditation for institutions categorized as accredited or not accredited rather than graded.
- Maturity-based graded Accreditation (level 1 to level 5) encourages accredited institutions to raise their bar from level 1 to level 4 as institutions of National Excellence level 5 as Global Excellence for Multi-Disciplinary Research and Education. Accredited institutions are classified into levels ranging from 1 to 5, with level 1 denoting low performance and level 5 reserved for institutions demonstrating global excellence.
- The National Education Policy (NEP) 2020 proposes integrating both institution- and Program-level accreditation. According to these guidelines, NAAC accreditation is mandatory, while NBA accreditation is optional for institutions.
- The primary recommendation is One Nation One Data (ONOD), which seeks
  to streamline data provision to agencies such as AICTE, NAAC, NBA, and
  NIRF within specific timeframes to avoid redundant data collection.



One Nation One Data (ONOD)

DQA indicated that data is submitted annually to AICTE and NIRF, every three or six years to NBA, and once every five years to NAAC. The committee aims to establish a unified data collection and validation platform. Prof. Muttan has suggested concentrating on how NEP 2020 and NAAC criteria are to be integrated; DQA assured him that he will look into it.

#### 22.6 To discuss activities and statistics aimed at enhancing placement outcomes

Dr. P. Vijayaraman, DCC, presented the present-year placement statistics. The table below shows the career choice distribution for 2024 passing students and placement statistics for 2024.

DCC has indicated that, besides attending placement drives, students are actively involved in training programs, mock interviews, and monthly contests, regardless of the academic schedule. DCC has briefed the committee that the decline in placements is attributed to a shift in the current trend towards pursuing higher studies. In 2022, 100 students opted for higher studies; in 2023, this number increased to 360. The below table shows placement statistics for 2024.

Prof. Muttan inquired about the difference between the number of students

enrolled (1244) and the number of eligible (1090). DCC said this is because of students' arrears, and most companies prioritize recruiting students without any backlogs for placement. Mr. Viswanathan inquired about feedback collection procedures and current actions. DCC informed that based on feedback, it introduced Mainframe specializations and recruited 30 students. Recently, the Institute has collaborated with Price Waterhouse Coopers (PWC) for cyber security training, Accenture for Spanish & Italian language training, AtoS for new computer science specialization programs, and Genpack for tech skills.

Mr. Ranjith A expressed concerns about the current low demand in companies and asked about the steps to address this issue. He highlighted the increasing demand for Artificial Intelligence (AI) and Large Language Models (LLM) in IT companies, which are also becoming essential for non-IT sectors. Dr. V. Srinivasa Rao, Dean SoC, informed the committee that they have been focusing on generative AI for the past six months, with approximately 500 students enrolled in related courses.

Mr. Viswanathan proposed faculty training for student instruction. Dr. V. Srinivasa Rao assured faculty training in AI, DS, and coding for upcoming academic years. During the initial two semesters, students will concentrate on mastering the fundamentals of the course, followed by advancing to tackle intricate challenges over the subsequent two years.

Mr. Viswanathan emphasized that non-IT companies were recruiting IT students due to high demand and stressed the importance of preparing students for job opportunities, suggesting additional training to improve their prospects. Prof. Muttan asked about brochures on previous company placements and suggested creating them if they don't exist to attract student interest. Mr. Viswanathan proposed a database on companies' preferences and preparation tips for future reference. Mr. Ranjith inquired about startup promotions. Mr. J.E. Simon shared his son's success story, highlighting the importance of supporting

startups. DCC preferred startup companies and assured their authorization verification.

## 22.7 To discuss strategies and activities to enhance opportunities for higher studies, both domestically and abroad.

Dr. P. Suresh, DINT, presented the AY 2023-24 activities. The AY 2023-24 highlight is shown in the table below.

DINT expressed that ETS India Private Limited has partnered with Vel Tech to establish an On-Campus Test Centre for English Proficiency exams (such as GRE, TOEFL, and GMAT) at discounted rates. DINT shared that international student mobility has improved this year after the pandemic. Mr. Viswanathan asked about capturing student interest towards higher studies, which DINT indicated would happen in the 3rd year. He also proposed encouraging students to take the GATE exam for improved placement opportunities, potentially benefiting Public Sector Undertakings (PSUs). Prof. Muttan discussed UGC's recent recommendation for joint degree collaborations, which DINT confirmed ongoing discussions with 25 institutions. Prof. Muttan suggested establishing

campuses in foreign countries like South Africa to promote education and highlighted the vision of internationalizing higher education at Vel Tech.

## 22.8 To explore the possibility of offering additional internships with academic credits to enhance students' employability.

Dr. P. Chandrakumar, Dean (DIND & TBI), outlined the minimum credit requirements for regular students across different course categories. DIND noted a decline in student participation in industry projects and internships due to a preference for credit courses recommended by industry or higher learning experts. DCC proposed conducting placement training and drives in the 7<sup>th</sup> semester to prevent disruptions caused by internships, suggesting a shift of internships to the 5th or 6th semester to maintain placement effectiveness.

DIND outlined different internship options. In the first option, students will be asked to fill out a willingness form at the end of the 5<sup>th</sup> semester to choose between internship or non-internship tracks. If a student opts for an internship in the 6<sup>th</sup> semester, they will complete pending coursework and their major project in the 8<sup>th</sup> semester. In the second option, students asked for a compulsory mini-project to be completed during the semester holidays.

Mr. Viswanathan suggested faculty industry training, supported by Prof. Muttan, who proposed that 10% of faculty undergo such training, which could have a national-level impact. Prof. Muttan stressed the importance of making the GATE exam mandatory for recruitment and aligning syllabi with its content. He proposed integrating GATE topics into teaching to avoid needing separate coaching.

For example, countries like India, USA, Japan, Germany, South Korea, Switzerland, Singapore, Sweden, and the UK.
- Item 07: Preference for ABDC indexed publications (A\*, A, and B category) for management scholars.
  - ✓ The committee recommended publications indexed by ABDC across different categories may be allowed adhering to the current norms outlined in the released circular dated 06-07-2023.

- Item 08: Revision of Publication requirements for Ph.D. scholars in the School of Law.
  - The committee considered requests from the Law and English departments concerning their publication requirements for Ph.D. scholars. The specified requirements for Ph.D. synopsis submission are as follows:
  - ✓ 2 Scopus or 4 UGC Care Journals
  - ✓ 1 Scopus + 2UGC Care Journals
  - ✓ The requirement should be met by utilizing peer-reviewed UGC Care journals preferably with ISSN numbers.
- Item 09: Action plan to address international scholars who have not reported after taking break of study in the Ph.D. program.
  - ✓ As the scholars on the list have not responded after reminders and have been inactive for two consecutive semesters, the board recommended consulting with Dean, Internation office and their supervisors before initiating the cancellation process.
- Item 10: Feasibility of admitting B.E / B.Tech students directly into the Ph.D. program with a valid GATE Score.
  - ✓ The board endorsed the initiative and recommended finalizing the eligibility criteria and to present it in the next meeting. This would entail admitting B.E/B.Tech students (from Engg./Tech.) with valid GATE scores into the full-time PhD program. The proposed minimum credit requirement was deemed acceptable, and their publication criteria will be aligned with those of all other scholars.

## Minutes of Meeting - Interface meeting with the Vice Chancellors of Deemed to be Universities, presided by the UGC Chairman at UGC Office, New Delhi

March 26, 2024

- 1. The emphasis should be on maintaining the quality of Ph.D. programs. The UGC may conduct random verifications of individual scholars' details from admission to graduation to ensure that institutions are adhering to all prescribed norms.
- 2. Uploading of Ph.D. thesis in INFILBNET.
- 3. Some universities are offering Ph.D. programs joint with IIT Mandi. A similar kind of collaboration shall be initiated by the Deemed-to-be Universities.
- 4. Multidisciplinary Education: Admission policies should include provisions to admit students from diverse backgrounds into all disciplines. For example, a student with a background in Economics at the school level should have the opportunity to pursue studies in Physics or Chemistry.
- 5. National Credit Framework Implementation:
  - The registration for Automated Permanent Academic Account Registry (APAAR) ID is mandatory for UG, PG and Ph.D. programs at the time of admission itself.
  - The Academic Bank of Credits (ABC) ID is to be linked with APAAR ID
  - Faculty members should be encouraged to utilize the "Malaviya Mission Teacher Programme" to familiarize themselves with the NEP 2020.
- 6. Institutional Development Plan (IDP)
  - To be prepared for 10 years plan
  - Intake to be doubled in the next 10 years
  - Infrastructure for Online education is to be established
  - UGC may invite the HEIs soon for discussion
- 7. **Internationalization:** The admission of a greater number of international students should be prioritized. To achieve this, roadshows and workshops should be organized in foreign countries to attract more international students to India. Additionally, focus should be placed on twinning programs, joint degree, and dual degree programs, particularly for institutions with a NAAC score above 3.01 and those ranked in the top 100 by NIRF.
- 8. More skill-based courses are to be included in the program
- 9. IPR policy should support more student startups
- 10. The candidates with UGC NET should only be admitted for Ph.D. programs. Institutions need not conduct separate entrance examinations.
- 11. Common University Entrance Test (CUET) for UG admission (Engineering, Medicine and other disciplines). Presently it is a Computer Based Test (CBT). Upcoming year it will be conducted in a hybrid mode (OMR Based). From May 15 to 25, the entrance exams will be conducted and the results will be declared between 2<sup>nd</sup> and 3<sup>rd</sup> week of June 2024.
- 12. More number of Professor of Practice are to be appointed.
- 13. UTSAH portal to be updated periodically.
- 14. All three year undergraduate programs are to be converted into four-year degree programs at the earliest.
